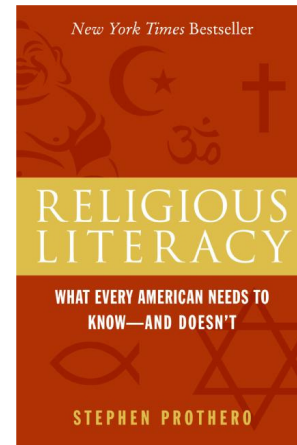
Dear friends:
